Dear Congressional Leaders:

We urge you to enact legislation at the earliest opportunity that would extend the carryback period for net operating losses (NOLs) and include AMT (alternative minimum tax) NOL relief. Such action would help struggling companies of all sizes – in all sectors of the economy – retain jobs, make critical investments, and in some cases, stay open for business.

A temporary extension of the NOL carryback period would provide an immediate infusion of cash for those companies most in need. Under current law, businesses may carry back losses for only two years, generating a tax refund to the extent of taxes paid in those years. Losses that cannot be absorbed in these two years are carried forward, for use against future taxes that may be owed. Legislation allowing companies to carry back losses to earlier profitable years would simply convert a future tax benefit into cash today, when it is most needed.

In the past, Congress has used NOL carryback relief as a ready tool to help lift the economy out of recession. Most recently, the Job Creation and Worker Assistance Act of 2002 provided a five-year carryback for 2001 and 2002 NOLs and AMT NOL relief. This action provided critical relief for struggling manufacturers, retailers, and companies in many other industries. In other instances, Congress has provided even longer loss carryback periods.

We would note that the “bonus depreciation” and “expensing” provisions were enacted as part of the Economic Stimulus Act of 2008. For companies in a loss position, however, increased current-year deductions generated by these provisions will provide little or no economic help. An expanded NOL carryback period is one of the few effective means of reaching companies most in need.

In short, an expanded NOL carryback period is a proven economic stimulus measure, one that can deliver vital help to our nation’s struggling employers. If there was ever a time for NOL relief, it is now.
